A MESSAGE FROM THE RACE STEWARD

"A new race season is approaching and the car preparation tempo is picking up. The new season brings a new Race Steward with new ideas. Racing is fun; that is why we have Conference! To keep racing fair, fun and as safe as possible is why we have a Race Steward.

Many have offered advice on how I should go about the Steward's job. A few points are in order - The Steward is responsible for enforcing the Competition Regulations, and I will; however, I don't intend to tour the pits nitpicking the Regs. There are many other details that need attention. If your competition is out of specification, exercise your rights and protest! If it appears to me that a car is out of specification, I may direct that car be torn down. Do not ask my opinion or advice that is really a concealed protest (Sec. 402A(5)). A car classification should be requested by the car driver and/or owner if it is not listed in Appendix A. The Competition Committee will be requested to advise on car classification requests and other matters as they come up. Scales will be available at all tracks, and weight checks will be made! Particularly in classes where weight is critical. Other spot checks will be made to determine compliance with the Competition Regulations in all classes.

In order to help do this, the Executive Board has authorized the position of Assistant Race Steward and the drivers, through the Contest Board, have developed a Competition Committee. Denny Goodwin is the 1978 Assistant Race Steward. His experience and knowledge in Conference racing and in formula cars will be a great help. The Competition Committee is made up of the Race Steward, Assistant Race Steward and 9 active drivers. Their names appear in the back of the 1978 Competition Regulations. They will have badges to identify them at the track and are responsible for driver representation and liaison. Make them feel good - talk with them!

There were over 30 significant rule changes this year. Read the new Competition Regulations carefully. Some major changes are in Section 502, Awarding of Points; Sec. 607, U.S.-Canada Border Crossing; Sec. 708, Production Car Gridding; Sec. 1001, Appeals to Contest Board; Sec. 1302, Car Classification; and Sec. 1402 C(9), Spoilers. A provisional Formula Ford 2000 class has been designated. It will compete with Formula Super Vee for trophies but will be scored separately for points. Provisional regulations are available from ICSCC Headquarters upon request.

Those that know me, know that I enjoy BS'ing about racing as much as anything. Stop by, let's talk, even differences can be worked out. There - I hope with these comments you are now looking forward to working with me as much as I am to working with you to have a fair, fun and safe 1978 competition season.

FROM THE DESK OF THE LICENSE DIRECTOR

My wife Stella (Assistant License Director) and I would like to welcome all Senior, ARR and Novice Drivers and all visiting competitors, to the fast approaching 1978 race season.

NOVICES: Apply for your license as soon as possible, don't wait until race day to have your license issued, only those with a "Driver Training Certificate" will be allowed in the Novice Program. All Novices MUST report to the License Director immediately after going through registration and before tech. inspection - don't get started off on the wrong foot, when you have questions, please ask.

ARR Drivers: Remember, even though you have been upgraded to A.R.R. status, you are still in the Novice Program and must report to the License Director after registration. ARR (X) drivers must display an "X" in order to practice and compete in Senior Events. The "X" must be displayed both front and back over day-glo panels, which can be purchased from the License Director.

IRR (Senior Drivers): Any holder of an IRR or ARR license who has not raced for one or two seasons must compete in a Novice Race before entering a Senior Race, and any IRR or ARR License holder who has not raced for three seasons must, in addition, take Driver's Training.

I will be going over all infraction sheets of Senior Races, and action will be taken on those Senior Drivers that keep reappearing on the infraction sheet. Let's keep Conference racing like it has been, FUN and SAFE, for everyone's benefit.

I would like to remind the Driver's Training Chairmen of the various sponsoring clubs that a complete and detailed description of your classroom and track work is required before approval will be given to Driver's Training Program. Such information should be available to me seven (7) days before your proposed Driver's Training.

Again, welcome to the 1978 season, I am looking forward to seeing lots of old faces and many new ones.

ATTENTION DRIVERS! - EXECUTIVE BOARD INITIATES NEW SPONSOR PASS

I am happy to report that the 1978 Executive Board is "tuned in" to the needs of drivers. The chemistry is very good this year on the Executive Board. The officers are very excited about the '78 season. The club reps are listening to each other, understanding the unique circumstances each club has to work with and supporting the overall efforts of the Executive Board. Doug has asked that they work collectively to support the drivers who in turn promote Conference Racing. I think it is going to be a great year!

By making it easier for Sponsors to attend races, hopefully they will become more active in supporting your competitive efforts. In return, you drivers can be more active in attending and promoting ICSCC racing. We all profit!

It shall be the goal of Conference to cater to the Drivers and Race Workers in our 1978 racing season. I am listing below some of what this new season will offer:

We have added a new item to race results - "SPONSORS" - we will only have space to list one per driver, so list your prime sponsor first on your entry form. The Executive Board approved a Sponsor Pass for 1978 that will be good at all tracks at any time of day for entry to grounds and paddock for all ICSCC events. A Sponsor Pass application form is enclosed in this memo.

The RACE OFFICIALS' DIVISION HANDBOOK has been published and will be sent to all licensed R.O.D. personnel. Added also is a new Day-Glo identification card.

Loren St. Lawrence and Steve Beckham have agreed to write a summary of each race weekend for our memo. We hope this will encourage all of you to come out and not miss any of the fun and competition they report. With good luck you could be reported. (Poor choice of words? If so, try "you could be lucky and get some good Press.") Please contact them and tell them what you would like to read.

The Contest Board created, and Bill Root has now formed, a Competition Committee. Their duties are to help Drivers and Officials as outlined in our 1978 Competition Regulations. Please read this new section and feel free to suggest additional areas they may be useful. If we all take advantage of their service, racing can only improve.

We will have the current ICSCC Championship points standings at all races to help your bookwork and encourage you to go for a Championship. We enjoy passing out awards at year's end.

ICSCC and CASC have worked out a good working agreement for 1978 that has solved the problems of the past seasons. We have Chuck Clemans and Tom Nelson to thank for working it out.

Upon entry, make sure that you are given two (2) copies. Upon leaving Canada, you "MUST" stop at Canadian Customs and turn in your copies. Make sure that the officials stamp and sign these copies and that one (1) copy is returned to you as your receipt. Failure to stop at customs and turn in your E29B forms will result in your license being suspended by ICSCC, upon our being notified by customs. Points earned at the event the E29B is dated will be voided. Upon clearance by customs and payment of a \$10.00 fine to ICSCC Headquarters, your license will be reinstated." (We will reprint this section with each Canadian Race Announcement. Please remember that only ICSCC licensed drivers can use this bond. Your crew cannot use it if they tow your car.)
