RE: PRODUCTION CAR CLASSIFICATION CHANGES

Following the guidelines set out in the Comp. Reg. 1302, I have taken the following action on the requests to reclassify the Production Cars,

DATSUN SSS: UNCHANGED. Based on qualifying times and finishing positions in 1980 and 1981 races I find that the SSS is a competitive E Production Car.

FUEL INJECTED RABBITS:

UNCHANGED. It was requested that Fuel Injected Rabbits run as pollution free. Based on information gathered, there seems to be very little difference in pollution equipment between carbureted and Fuel Injected Rabbits.

RABBITS RUNNING D.O.T. TIRES:

UNCHANGED. Comp. Reg. 1302. E. (7) states: Cars running D.O.T. or M.O.T. approved ties will be allowed to drop down one class,... This request must be considered by the Contest Board at the Fall Meeting, not the Race Steward.

DATSUN 1200:

UNCHANGED. The qualifying times and finishing positions show the Datsun 1200 to be a very competitive car. However, other cars have won the class, and placed second numerous times.
